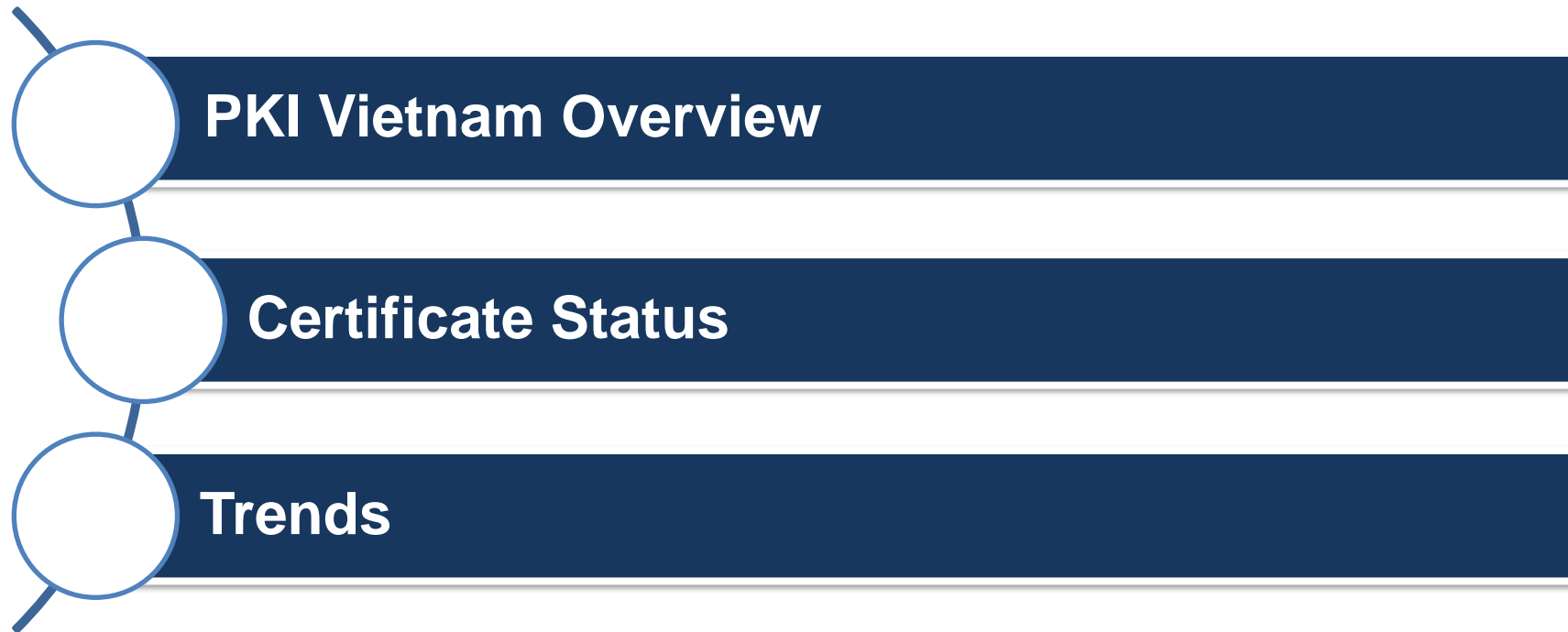

# PKI related organizations

## ❖ Root CA:

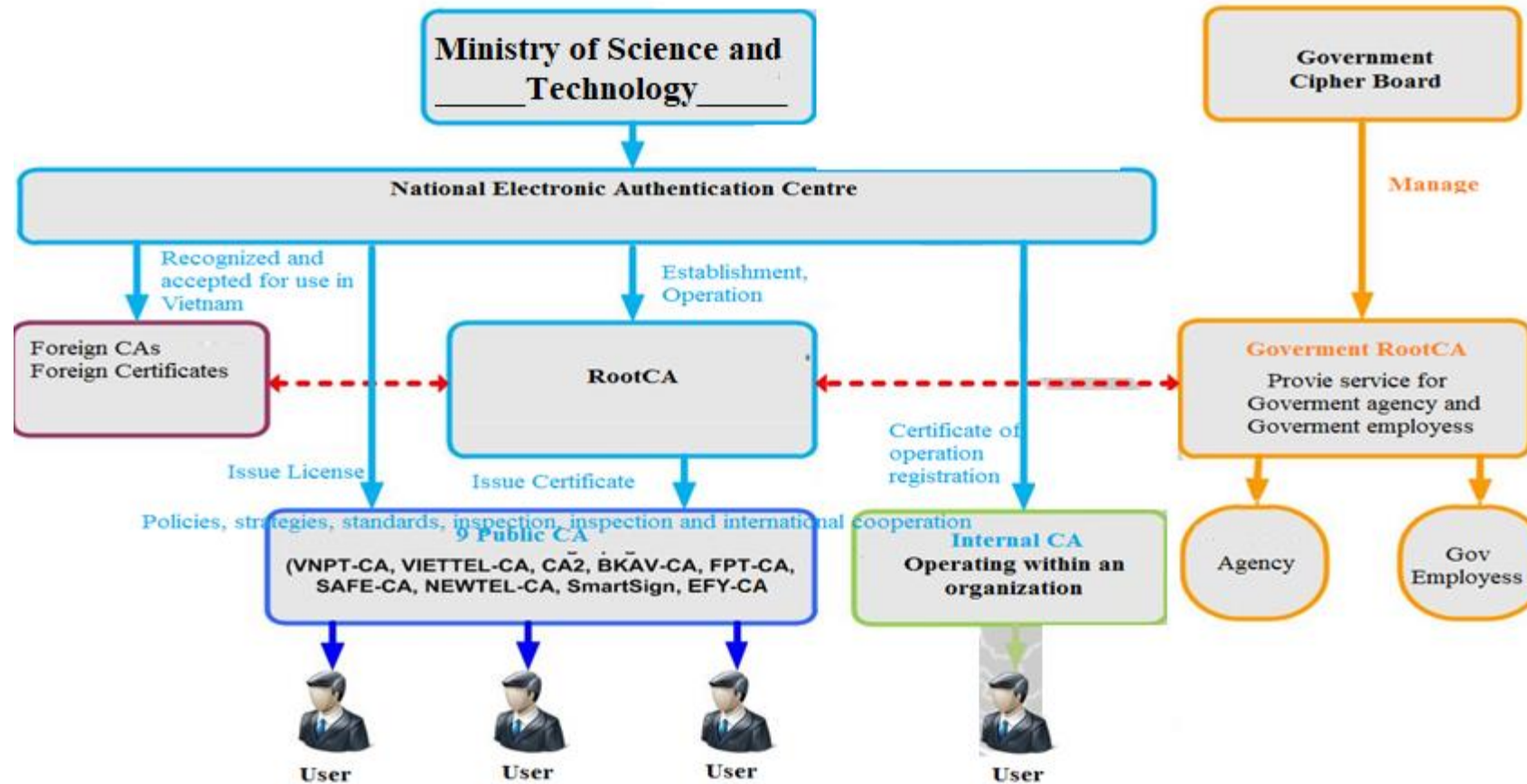
- Managed by NEAC, Root CA performs role of operation information security infrastructure that includes electronic authentication and PKI based services.

## ❖ Public SubCAs:

- Providing digital certificate service in Vietnam.
- License issued by NEAC is required.
- Currently 25 public SubCAs received the license to provide digital certificate issuance services.

## ❖ Vietnam Government Root CA (VGCA):

- For government agencies and officials.
- Total number of active Government digital certificates in May 2025: 805,381 digital certificates, an increase of 11.94% over the same period in 2024 (719,441 digital certificates).

## **Circulars/regulations in the management of trusted services in Vietnam include:**

- Recognition of foreign electronic signatures and foreign electronic signature certificates in Vietnam;
- Technical standards for trusted services
- Technical requirements for digital signature software and digital signature verification software
- Interconnection between Government Root CA and National Root CA.
- Technical audits.

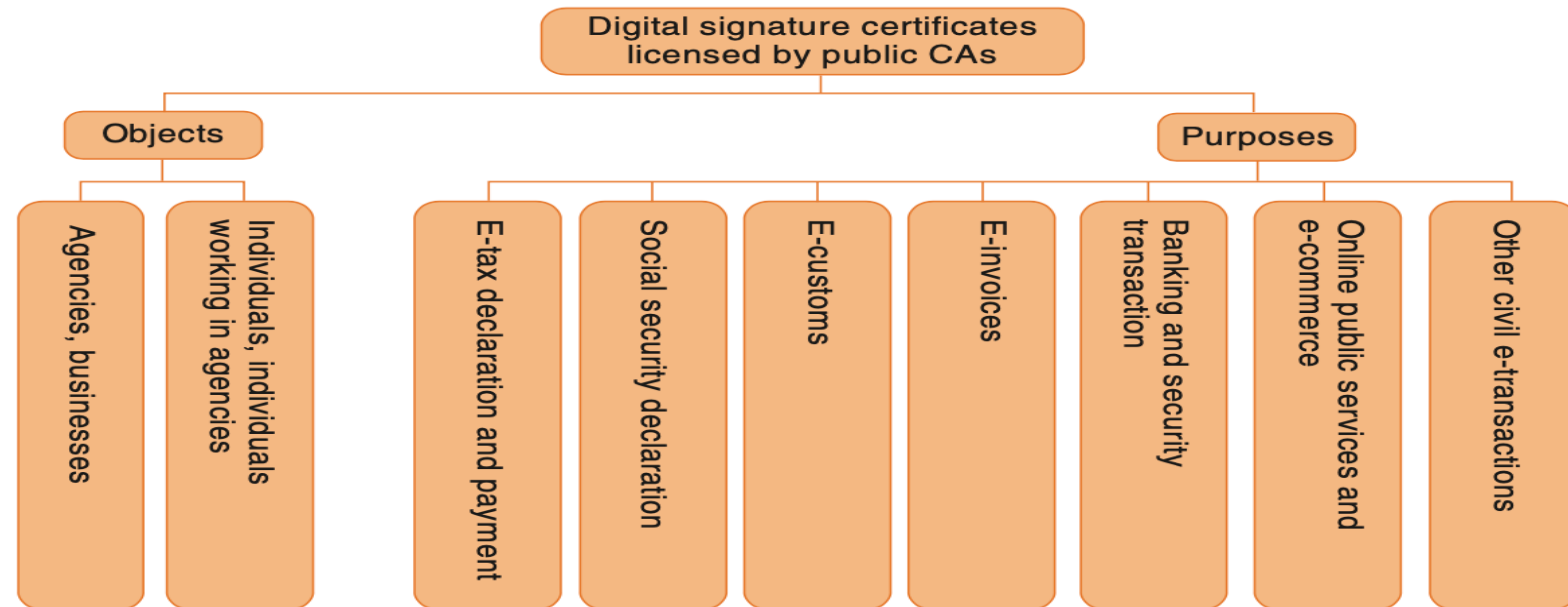
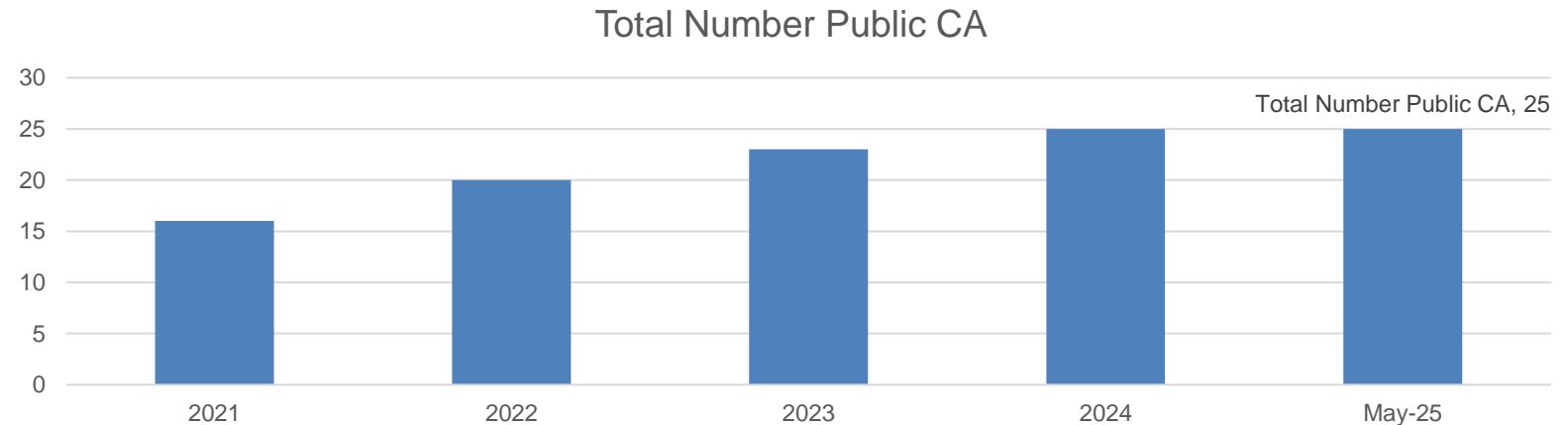
# Market & Services

## ❖ In May 2025:

- Total number public CA: 25 CAs
- CA that has remote signing service: 13 Cas

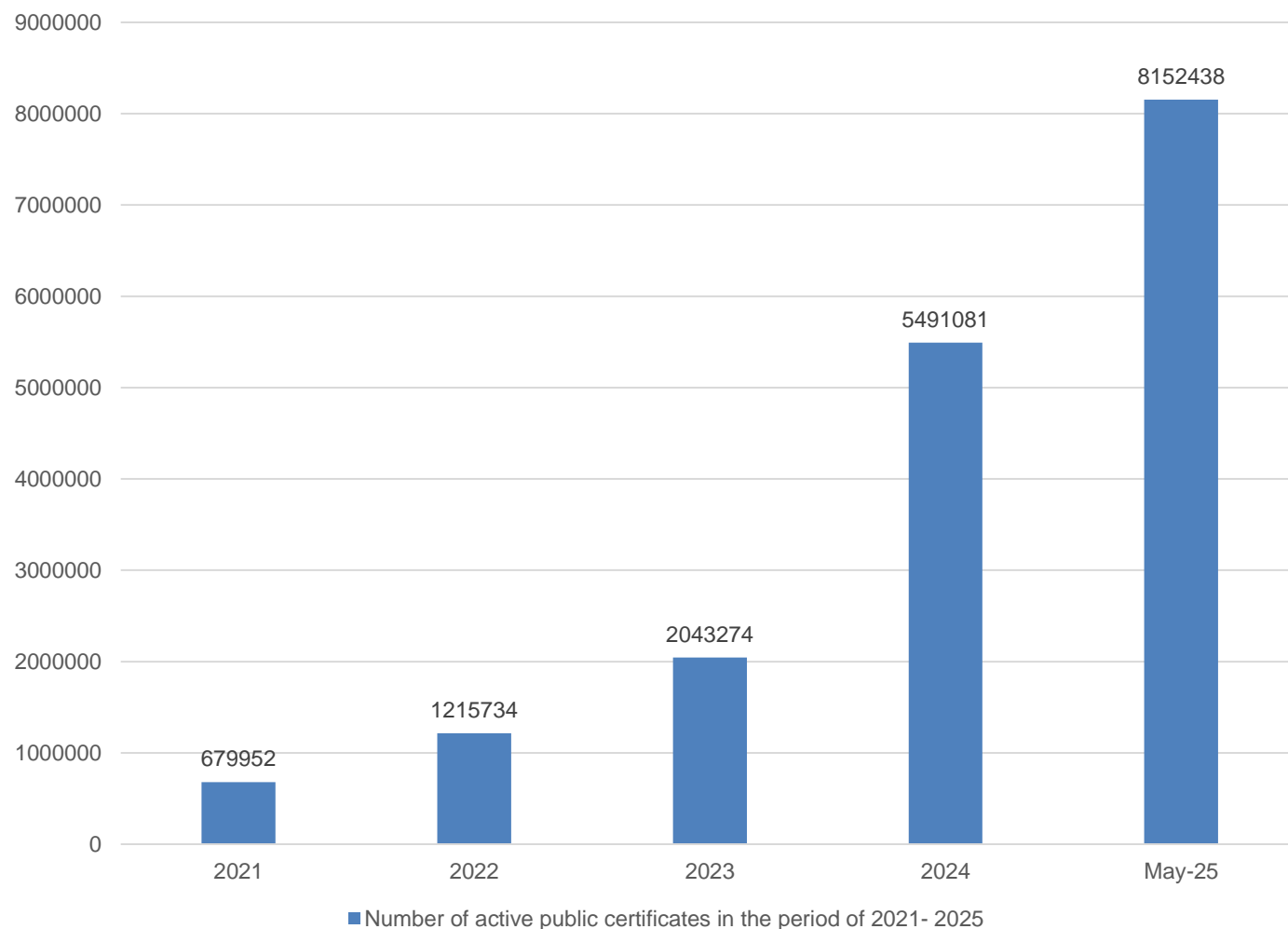
## ❖ Main purposes of digital signatures:

- Tax declaration.
- Social insurance claiming.
- Customs declaration.



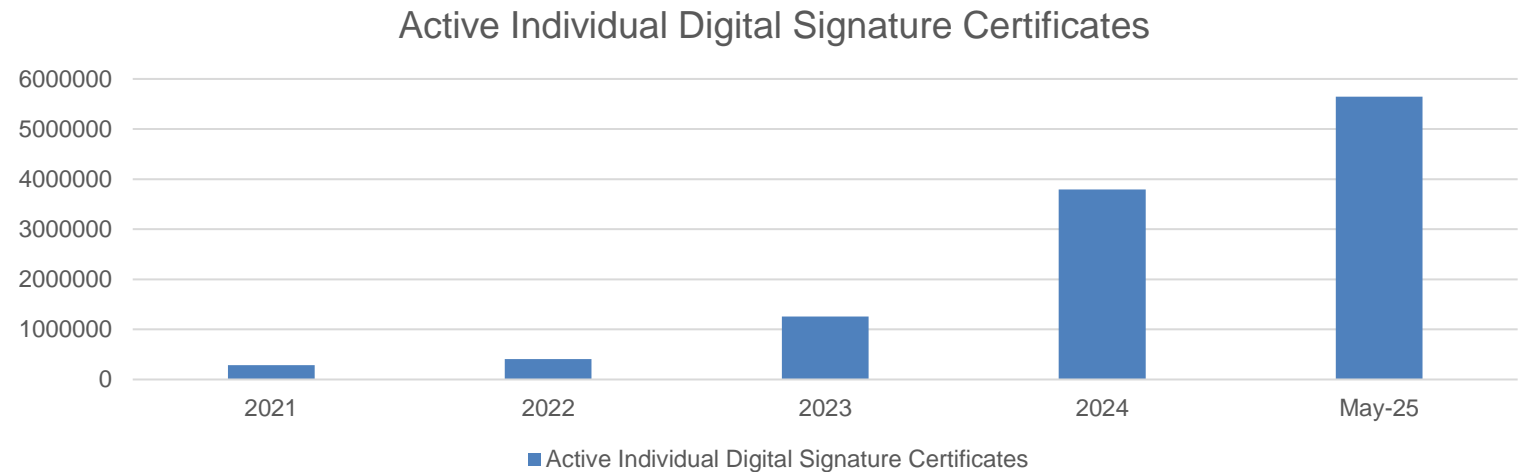
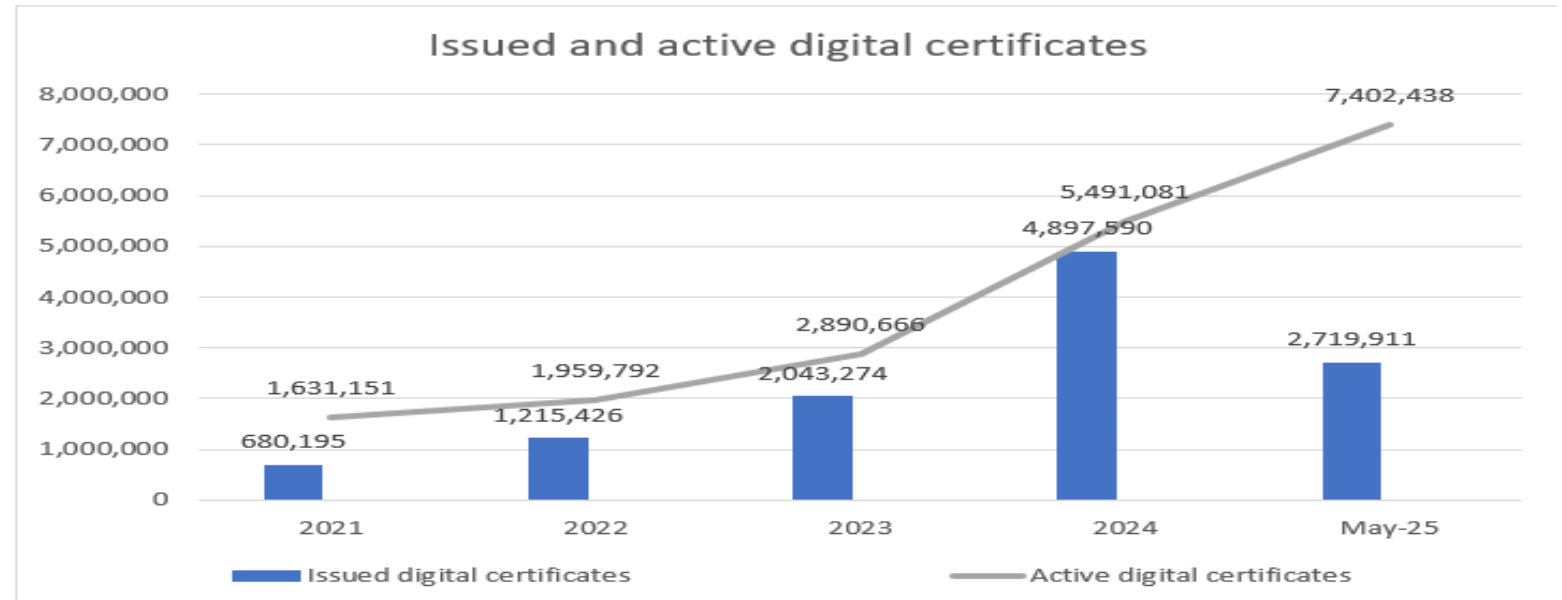
## Public digital signatures

- ❖ Total number of public digital certificates issued by the end of April - 2025: **16,258,905 digital certificates**, an increase of 84.73% over the same period in 2024 (8,801,083 digital certificates).
- ❖ Approximately 2.71 million public certificates already issued (April - 2025).



## Public digital signatures

- ❖ 8.15 million public certificates have been activated, an increase of 150.14% over the same period in 2024 (3,259,066 digital certificates).
- ❖ Percentage of adult population with digital signature: 27.7%
- ❖ Customers set: legal entities, end-entities (individual customers).

## **Trends/ Orientation**

The Government of Vietnam determines that the development of digital government and digital commerce is associated with information security, enhances transparency, improves service quality, and brings satisfaction to the people.

- Develop remote signing and mobile PKI
- Prioritize the development of personal digital signatures
- Expanding application scope: E-payment, e-banking, ...
- Application to electronic citizen identification
- Building trust service portal for integrating with all public and private services, to promote the use of digital signature.
